I AGREE TO INDEMNIFY AND HOLD HARMLESS THE RELEASEES, AND EACH OF THEM, FROM ANY LOSS, LIABILITY, DAMAGE, OR COST, INCLUDING REASONABLE ATTORNEY'S FEES, THAT ANY OF THEM MAY INCUR AS A RESULT OF, ARISING OUT OF OR IN CONNECTIONS WITH MY PARTICIPATION IN THE RODEO OR MY PRESENCE ON THE RODEO GROUNDS DURING THE RODEO WHETHER CAUSED BY NEGLIGENCE OF RELEASEES OR OTHERWISE.
